- 3. Your personal data will be processed in accordance with the GDPR for purposes arising from the organization and participation in the LPR jubilee event. The processing of personal data is related to the fulfillment of the Data Controller's legal obligations under Article 6 point 1 letter c of the GDPR and is due to the nature of our business, which is unique in Poland. Your participation in the Gala results from the organization of the event.
- 4. We have your personal data because we have obtained it from publicly available sources, as a result of long-standing cooperation or on the initiative of persons known to you, e.g., those reporting on your merits, regulatory authorities. The address data obtained in this way will be used to send information related to the organization of the event, and is processed on the basis of Article 6 point 1 letter e of the GDPR. To prepare news coverage of the Jubilee Gala for the purpose of documenting activities and promoting LPR activities. The event will be recorded by means of image and/or sound recording devices, in photographic form and as a audio and video material. In such a case, your participation in the event will be tantamount to your granting your consenting to the publication of your image, as provided for under Article 81 clause 1 of the Law of February 4, 1994 on copyright and related rights (Journal of Laws date 2025 item 24, as amended) and to the usage of such an image in materials promoting the event, including those published in the form of photos, without additional compensation, on the website: www.lpr.com.pl or in LPR's social media.
- 5. Pursuant to Article 81 clause 2 of the copyright and related rights, permission is not required to distribute the image of:
 - a. a well-known person, if the image was taken in connection with the performance of public functions, in particular political, social, professional;
 - b. of a person representing only a detail of a whole, such as a gathering, a landscape, a public event.
- 6. Your personal image data may be processed in accordance with the GDPR for the purpose of documenting the event and informing about the entity's activities and publishing your image for promotional purposes of the Data Controller also in the form of photographs on the LPR website(www.lpr.com.pl).
- 7. Your personal data indicated above will be kept for the period of the Data Controller's statutory activities and during the archiving period in accordance with the Regulation of Prime Minister dated January 18, 2011 on the Registry Instruction, uniform material lists of files and instructions on the organization and scope of activities of company archives, perpetually. In addition, we would like to point out, where applicable, that the personal data may be used for:
 - a. the implementation of the evaluation process, i.e. sending thanks for participation or materials from the event in accordance with Article 6 point 1 letter of the GDPR;
 - b. to fulfill LPR's legal obligations under the law, such as consent management, document archiving Article 6 point 1 letter c of the GDPR;
 - c. to pursue LPR's legitimate interests, such as protection of persons, property and information,
 - including with the use of video surveillance, and establishment, defense or possible enforcement of claims Article 6 point 1 letter f of the GDPR;
 - d. to keep statistics of the event's viewership Article 6 point 1 letter f of the GDPR;
- 8. Your participation in the Jubilee Gala may also involve the implementation of Article 6 clause 1 letter f of the GDPR, pursuant to which data processing may be carried out in order to pursue the legitimate interest of the Data Controller to contact you for possible claims, to protect people and property belonging to the Data Controller.

- 9. The recipients of your personal data will be persons authorized by the Data Controller and entities processing data on behalf of the Data Controller, in particular: providers of external ICT systems, supporting operations.
- 10. Personal data will not be intentionally transferred outside the European Economic Area (EEA) subject to publication and dissemination of data on social media or through the YouTube platform. Data will be duly protected based on the applicable regulations, which are at different levels in different countries, but taking into account the analogous level of protection to EU regulations applied by data recipients (e.g. privacy shield certificate). Social media providers describe data protection rules in their own portal privacy policies.
- 11. You have the right to request from the Data Controller access to your personal data, regarding rectification, erasure, restriction of processing and data portability. The right can be exercised in person, by mail or by sending a message to the email address indicated above in point 1. You have the right to complain about the actions of the Data Controller to the President of the Office for Personal Data Protection ul. Stawki 2, 00-193 Warsaw.
- 12. Pursuant to your consent, LPR may also process a particular image for the purpose of promoting its activities, as well as building a good image of LPR. Consent to the processing of personal data may be withdrawn at any time without affecting processing that took place before the withdrawal.
- 13. Automated decision-making, including profiling, will not be performed with respect to you. Data will be processed in traditional form and electronically.
- 14. The Data Controller shall make every effort to provide all means of physical technical and organizational protection of personal data against accidental or intentional destruction, accidental loss, alteration, unauthorized disclosure, use or access, in accordance with all applicable laws.
