### The Rules And Regulations Of The LPR Jubilee Gala

# I General provisions

- 1. These Rules and Regulations (hereinafter: "Rules and Regulations") govern the rights and obligations of the Participants of the LPR Jubilee Gala (hereinafter: "Gala"), organized in connection with the 25th anniversary of the establishment of Lotnicze Pogotowie Ratunkowe.
- 2. The organizer of the Jubilee Gala is Lotnicze Pogotowie Ratunkowe, ul. Księżycowa 5, 01-934 Warsaw (hereinafter: "Organizer").
- 3. The Gala is scheduled to take place on May 15th, 2025 at the Warsaw EXPO XXI Center (ul. Prądzyńskiego 12/14, Warsaw) between 1:00 P.M. and 6:00 P.M., within a separate zone (part) hereinafter referred to as the Gala area. The Organizer allows extending the duration of the Gala.
- 4. The provisions of the Rules and Regulations shall apply to all Gala Participants.
- 5. The Organizer shall be responsible for ensuring safe and comfortable conditions for participation in the Gala,

and the Gala Participants shall be responsible for respecting the rights and freedoms of other Participants, as well as the property of the Organizer.

- 6. Each Participant in the Gala is obliged to familiarize himself/herself/themselves with the contents of these Rules and Regulations. Entering the Gala area shall be tantamount to your having read and accepted these Rules and Regulations.
- 7. The Rules and Regulations are made available to the Gala Participants through:
  - a. posting on the Organizer's website <u>www.lpr.com.pl</u> with the information clause under the GDPR tab;
  - b. making information available to Gala Participants in hard copy by placing it on the notice board at the entrance to the Gala area;
  - c. making information available at the reception desk in the Gala area during the event, and at the Participant's request.
- 8. The Organizer shall make the Rules and Regulations available to the Gala Participants in order to familiarize them with the terms of participation, including the rights and obligations of the Gala Participants, the rules of admission, the rights and obligations of the Organizer, the responsibilities of the Gala Participants, and to ensure safety and rules of conduct in accordance with the law.

# II. Organizational and housekeeping rules

- 1. Participation in the event is free of charge and is planned for up to 499 people.
- 2. The Gala may be attended by invited persons its Participants. For organizational reasons, and in particular to ensure safety, confirmation of the Participant's participation should be made by phone (phone 22 22 99 918) or by email (jubileusz@lpr.com.pl) by April 11, 2025; you are kindly requested to state your first name and surname when confirming your presence. Only an adult can be the Participant in the event.
- 3. Those who have not been previously notified to the Organizer will not be able to participate in the Gala.
- 4. The Organizer provides the Gala Participants with organizational and informational support, medical assistance, hygiene and sanitary facilities and fire safety. During the Gala, Participants agree to observe fire safety rules.
- 5. The Organizer shall not be responsible for any items lost or left in the Gala area and unattended by their owner.
- 6. It is the duty of each Participant to respect other Participants, and the rules regarding safety, especially applicable Organizer's instructions.
- 7. Admission or participation in the event is denied to persons who are under the influence of alcohol or drugs.
- 8. The Participant shall be held financially responsible for damage caused by him/her/them to other Participants as well as for damage caused to the Organizer's property.

#### III. Protection of personal data, including image

- 1. Personal and image data of the Gala Participants are processed on the basis of Article 6 Regulation of the European Parliament and of the Council (EU) 2016/679 dated April 27th, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46/EC (hereinafter: "GDPR"), and for persons with visible disabilities in accordance with Article 9 of the GDPR.
- 2. The processing of personal data, including in the form of an image, shall be carried out on the basis of a legal obligation incumbent on the Data Controller (Article 6 clause 1 letter c of the GDPR) and the legitimate interest of the Data Controller (Article 6 clause 1 letter f of the GDPR) or consent to process data for one or more specified purposes (Article 6 clause 1 letter a of the GDPR), and for archival and historical purposes (Article 89 of the GDPR). This processing is carried out in accordance with

national regulations, including with the Regulation on the Registry Instruction, Uniform Substantive Lists of Files and the Instruction on the Organization and Scope of Operation of Company Archives (Journal of Laws No. 14 item 67 dated January 18th, 2011 as amended). In addition, during the Gala, image processing shall be carried out pursuant to on Article 81 of the Law of February 4th, 1994 on copyright and related rights (Journal of Laws 2025 item 24, as amended; hereinafter: "Copyright Law"). In such cases, the image may be disseminated without territorial and temporal limitations, in particular by posting the photographs on the Organizer's websites and other electronic media managed or used to any extent by the Organizer. In addition, it may also be included in publications and third-party services, provided that they relate to the Organizer's activities. The use of these images by third parties for their own purposes shall be prohibited.

- 3. The Organizer shall record on electronic, optical or paper devices and media the Gala for the purpose of documenting the event, and then collecting archival documentation of the LPR, perpetually and in accordance with the Regulation on the Registry Instruction, Uniform Substantive Lists of Files and the Instruction on the Organization and Scope of Operation of Company Archives (Journal of Laws No. 14 item 67 dated January 18th, 2011 as amended).
- 4. The actions taken by the Organizer to document the event are related to its unique activities on a national scale and its legitimate goals and designated tasks as a public entity related to therapeutic activities.
- 5. Moreover, pursuant to the provisions of the GDPR, the image may be processed based on the premise: Article 6 clause 1 letter c of the GDPR - in the case of video surveillance used for security purposes and protection of persons and property at the Gala.
- 6. The processing of Participants' personal data, including their image, is carried out by the Gala Organizer for the purpose of documenting LPR's activities, and thus the Gala Organizer confirms that the processing is necessary to fulfill the Data Controller's legal obligation (Article 6 clause 1 letter c of the GDPR) and the performance of tasks carried out in the public interest (Article 6 clause 1 letter e of the GDPR) in relation to Event Participants Article 6 clause 1 letter c of the GDPR; processing is necessary for the fulfillment of the Data Controller's legal obligation under the Act of July 14, 1983 on national archival resources and archives (Journal of Laws 2020 item 164, as amended ), the documentation produced will be archived in perpetuity (according to the JRWA classification).
- 7. Recordings and images of people attending the Gala may be recorded on any media, and then distributed (to notify others about the Jubilee) by all kinds of media for documentation, reporting, educational, promotional purposes, etc. for the needs of any media outlets that exist today, in particular: press, television, social media, the Internet. The image may also be captured and disseminated by third parties for whom the Organizer cannot be held responsible.
- 8. Confirmation of participation in the Jubilee Gala is tantamount to consent to the processing of personal data, including image capture (Article 6 clause 1 letter a of the GDPR) for the purposes specified in the Rules and Regulations, and in particular related to registration and participation in the Gala, as well as acceptance of the Rules and Regulations.
- 9. Pursuant to Article 81 clause 2 of the Law on Copyright and Related Rights, permission is not required to distribute the image:
  - a. a well-known person, if the image was taken in connection with the performance of public functions, in particular political, social, professional;
  - b. of a person representing only a detail of a whole, such as a gathering, a landscape, a public event.
- 10. The Organizer shall not be responsible for the dissemination of the image made by other participants in the event without the consent of the owners of the image. However, within the framework of the Rules and Regulations, the Organizer of the Gala calls on Participants to refrain from capturing the image of specific strangers without their consent, especially to share it on the Internet.
- 11. The use of personal data includes the dissemination of the image captured in images, including moving images, taken during and in connection with its participation in the Gala, in particular, as follows:
  - a. Reproduction of copies of the recording of the image by any technique, including printing, reprography and digital technique; free marketing of copies of the recording of the image;
  - b. making the recording of the image available to the public in such a way that anyone can access it at a place and time of their choosing, in particular on websites, social networks, mobile applications;
  - c. dissemination of image recording with the use of e-mail;
  - d. public display and reproduction of the image recording or exhibition of copies of the image recording to the public.
- 12. The text of the information clause on personal data protection may be found on the Gala Organizer's website <u>www.lpr.com.pl</u> under the GDPR tab.

13. The jubilee may be held with the participation of journalists who will prepare and present materials in the mass media.

### **IV. Final provisions**

- 1. The Organizer reserves the right to change the time and program of the Gala.
- 2. The technical equipment located in the Gala area may be operated only by authorized persons or under their direct supervision. Access to these devices is allowed only with the permission and under the supervision of an authorized person.
- 3. In cases not regulated in the Rules and Regulations, the provisions of the Civil Code shall apply.
