### **ANSWERS TO COSTRACTORS QUESTIONS**

**Regarding: Open tendering procedure for: “Purchase on exchange 2 (two) brandnew PT6A-66B engines for replacement for the Piaggio P.180 aircraft” (Procedure no:ZP/4/VII/2021)**

The Polish Medical Air Rescue [LPR] as the Awarding Entity, acting pursuant to Article 135 section 2 and 6 and Article 137 section 1 of the Act of 11 September 2019. Public Procurement Law (Journal of Laws item 2019, as amended) hereinafter referred to as the "Act", informs that questions have been received from Contractors, to which the Awarding Entity provides the following answers and amends the content of the ToR:

#### **Question no. 1:**

In connection with the published procedure number ZP/4/VII/2021 for the replacement of PT6A-66 engines, I would like to address the following issues to you.

##### **1. Tender submission dadeadline**

The procedure documentation indicates the tender submission dadeadline on 03/08/2021. Due to the high value of the potential transaction and the necessary preparatory work required to submit a tender, we would ask you to extend the tenders submission dadeadline by 31/08/2021. Taking into account that the procedure was published on 23/07/2021, which means that suppliers have been given 10 calendar days to prepare their tenders.

##### **2. Engines documentation**

Since the engines currently owned by the LPR are to be transferred in settlement for brand new engines, we would ask for access to the documentation of your engines, which will allow to perform valuation of their value at the time of transfer. In particular, we need information such as TSN, CSN, TSO, CSO, SB/AD status, LRU status, LLP status.

#### **Question no. 2:**

We herewith request an extension to the submission date for your tender with reference number ZP/4/VII/2021, covering the “Purchase on exchange 2 (two) brand new PT6A-66B engines for replacement for the Piaggio P.180 aircraft” from 3rd August 2021 at 12:30 PM (refer to section 16, article 1 of the ToR) to 12th August 2021 at 12:30 PM.

The reason for this extension request is the very short given timeline to prepare our proposal together with all required documentation.

#### **Answer:**

**Pursuant to art. 137.6 and art. 90.2 of the Act, the Awarding Entity shall change the content of the ToR by changing the tender submission deadline and the tenders opening deadline as follows:**

**Tenders submission deadline: 12.08.2021 at 12:30 pm**

**Tenders opening deadline: 12.08.2021, at 1.00 pm**

**Therefore the Contractor shall be bound by the tender from the tender submission deadline to 5.11.2021.**

**In addition, the Awarding Entity shall publish the technical documentation of the engines to be replaced as part of the delivery of brand new engine.**
